### 1. VOLUNTARY CONTRIBUTIONS

Contributions are voluntary and have been set at \$60 per child K to 6. This is an important revenue source and supplements the school expenditure in the areas of:

- Laptop and iPad upgrades and classroom resources.

### 2. CHARGES

The charges relate to the costs that are associated with additional activities that are associated with the delivery of educational programs. Children are required to pay the charges prior to participating in the learning activities. The amount indicated in the Schedule represents the maximum amount that could be charged in 2019.

### 3. PERSONAL USE ITEMS

All students K – 6 will receive a Personal Use Items List for their 2019 year level. These are the items that students will require for use throughout the year.

### 4. P&C VOLUNTARY CONTRIBUTION

The P&C requests a voluntary contribution of \$30 per family. The P&C generously supports the school in the provision of funds for a range of items including: iPads; playground equipment; and resources.
